## I. Subsequent Reviews

- Title Sheet – Including ADA note about access in the R.O.W.
- Brief project description of activities
- Existing Conditions Sheet
- Demolition Sheet
- Erosion/Sediment Control and Tree Protection Barricade Plan/Details Sheet
- Rough Grading Plan /Surcharge Plan
- Test Pile Only Plan

Additional Information that may be required includes, but is not limited to the following (notice to be given at Pre-App meeting)

- Traffic Impact Study and Truck Route Plan
- Construction Activity Application with Supporting Documentation
- Comprehensive Stormwater Pollution Prevention Plan
- Approved Plat
- City Encroachment Agreements
- Permits from Other Agencies

\*The necessity of these items shall be determined at a Sketch Plan Meeting Review. If required, the applicant shall provide documentation of their status as part of the submittal for subsequent reviews. Any issues shall be resolved with the appropriate TRC member.
