This application is for an operational permit to erect a temporary structure that meets the permit required threshold identified in the South Carolina Fire Code. Applicants must possess a current City Business License and obtain a permit, before operating, by submitting this application and the associated supporting documentation. The permit is only valid for the duration or approved timeframe. Temporary structures shall not be erected for a period of more than 180 days within a 12-month period on a single premises. Temporary Tent and Membrane Structure Application

Category of Temporary Structure (check one appropriate category)

A	Category A: Tents with one or more sides and membrane structures >400 sq. ft. and <1,000 sq. ft., tents open on all sides (canopies) >700 sq. ft. and <1,000 square feet, will not include cooking, and utilized for <50 people.
B	Category B: Tents and membrane structures >1,000 sq. ft. and <7,500 sq. ft., will not include cooking, and utilized for <250 people.
C	Category C: Tents and membrane structures >1,000 sq. ft. and <7,500 sq. ft., will not include cooking, and utilized for >250 people and <1,000 people.
D	Category D: Tents and membrane structures >1 story, or >7,500 sq. ft. or >1,000 people, and will not be used for cooking. Additional Building Permits may be required.
F	Category F – Food: Open or enclosed tent utilized for cooking or food preparation, at one location, for <7 days or the duration of a special event. Intended for vendors who have not obtained a mobile food vendor permit. Note: multiple small cooking tents may be grouped together when the total area is <700 sq. ft., with 12' between each tent within the aggregate area, and 20' to the next tent or group of tents. Each cooking operation will need an individual permit.
