### **Abstract**

This collection consists of the papers of the E. Edward Wehman, Jr., the fifty-sixth mayor of Charleston, who served from 1944-1947. The collection contains correspondence, newspaper clippings, meeting minutes, along with various municipal documents.

### **Biographical Statement**

E. Edward Wehman, Jr., was born in Charleston to Bertha T. and E.E. Wehman in 1891. He attended West Point from 1911-1912 where he studied alongside classmate Dwight D. Eisenhower. He later graduated from the University of South Carolina with a Bachelor of Science before going on to a career in the insurance industry. He served as alderman representing the city's sixth ward during the 1940-1943 administration of Mayor Henry W. Lockwood, a position to which he was reelected in 1944. Upon the untimely passing of Mayor Lockwood that same year, Wehman was selected by his fellow councilmembers in a 16-7 vote to fulfill the remainder of Lockwood's term. After three years in office, Wehman chose not to run for reelection, instead returning full-time to his insurance business.

## Scope and Content Note

The collection is organized alphabetically according to subject, document type, or the originating individual, organization, or city department. The papers consist of correspondence, meeting minutes, newspaper clippings, proclamations, and resolutions. Subjects of interest include demobilization during the postwar period, the establishment of the State Ports Authority, development of the Charleston Municipal Airport, and postwar racial conflicts. Of special interest to students of African American history is the role of military institutions and black soldiers in the push for voting rights and equal facilities.
